COUNTY EXECUTIVE LEOPOLD TO SPEAK AT ANNUAL MEETING OF HCA

Board Election Also on Agenda

On Wednesday, February 28, at 7:00 p.m. in the Media Center of Southern High School on Solomon's Island Road, the Harwood Civic Association will hold its annual meeting. The year's budget will be approved, an election for new board members will be held. Reports of the previous year's activities will be shared. And newly elected County Executive John Leopold has agreed to make the meeting one of his first stops in getting to know the concerns and issues facing South Ann Arundel County.

As part of its commitment to the residents of Harwood, the HCA invites elected officials to speak to the membership at this key event. The new county administration has signaled some important changes in addressing zoning enforcement, and approaches to the environment. This meeting provides an excellent opportunity for Harwood citizens to impact the new administrative agenda for the county.

The business portion of the meeting is expected to be brief as always. It includes approval of a budget for the year and sharing the results of the on-site election of new board members and officers. (See the article on page 7 for information on the slate of board candidates.

Analysis of Implementation of South County Small Area Plan

In 1998 a diverse group of citizens from South County came together to host an International Stewardship Exchange program during which experts from around the world offered recommendations on how to keep South County Rural and enhance our quality of life. The South County Exchange (Exchange) is one product of this intense effort. Working with local landowners and residents, the Exchange aims to protect the rural way of life that makes South County a special place to live. Among our efforts have been surveys of recreational needs in the South County and of Deale-Shadyside planning areas; acting as principal coordinator for creation of the Patuxent River and costal Greenways; and, analyzing the impacts of family conveyance on the rural character of lands zoned residential agriculture.

The Exchange is following implementation of the South County Small Area Plan (SAP), a collaborative effort between county agencies and a diverse citizens committee that provides local detail for implementation of the AA County 1997 General Development Plan. The dominant theme of this plan is "Keep South County Rural". To examine how the County has progressed toward implementing this plan, the Exchange convened a small group of community leaders to look at the plan's recommendations and the extent to which they have been met. Three members of the planning committee, including the Chair of the Land Use Planning Committee, were involved in this process. Following is their assessment of the County's progress toward meeting these objectives:

Preserve the Agricultural and Rural Lifestyle

Accomplishments:

1. RA Zoning strengthened by elimination of family conveyance provision
2. RA zoning modified to allow farm based commercial efforts
3. Continued acquisition of land for agricultural preservation. 12,000 acres. protected.
4. 1,000 acres of farmland being acquired to be used as showplace of new agricultural products and BMP's. Farm tours will be held to educate public about agriculture.
5. Right to farm legislation passed.
6. Funding allocated for preservation of historic barns.

Critical Tasks Requiring Action:

1. The county has only achieved 60% of the 2007 agricultural preservation goal.
2. A serious analysis of TDRs (transferable development rights) providing an innovative look at how they can be used has not been performed.

3. The county does not know how much further development is possible under current zoning, including development of already approved family conveyances and platted lots, particularly along the shore.

Economic Development

Accomplishments:

1. Zoning revised to allow appropriate home-based businesses
2. Staff member reassigned at AA Economic Development Corporation to promote agricultural products.
3. Rural Heritage Program established.

Critical Tasks Requiring Action

1. A comprehensive plan to ensure long-term success for agriculture needs to be a top priority. The Economic Development Corporation's marketing activities will not stabilize agriculture.

Land Use and Community Design

Accomplishments:

1. Restrictions placed on large non-agricultural uses in RA zoning district, including elimination of some uses.
2. Time limit placed on initiating building of subdivisions and commercial structures after final approval.
3. Regulations established for Historic and Scenic Roads
4. Subdivision regulations revised to promote cluster development.
5. Conservation easements established on several areas including 300-acre site north of Fairhaven. Hundreds of small lots covered by forested non-tidal wetlands near Fairhaven protected by community association agreement.

Critical Tasks Requiring Action:

1. Sand and Gravel Mines represent a continuing threat of more landfills. The SAP calls for eliminating landfills as a permitted use.
2. Zoning of Wayson's Corner needs to be revised to implement the recommendation of the SAP that national franchised big box development and strip malls are not consistent with the rural character of South County.
3. Many of the Plans most important recommendations remain to be fully implemented: Rural design standards, Patuxent River Overlay Distract, transportation study.

Natural and Historic Resources (Protection of Patuxent Greenway)

Accomplishments:

1. Hundreds of acres have been acquired by

LONG TERM MONITORING of PST LAND FILL GROUND WATER POSSIBLE

Potentially serious threat to public health

The PST rubble landfill on Sands Rd. in Harwood operated between December 1992 and July 1, 2001. Between 1997-2001 PST received almost 2 million tons of waste. Over 80% (1,548,062 tons) came from generators outside of Anne Arundel County. To grasp the scale of this operation, consider that during the same period the Millersville landfill received 509,068 tons. PST received 4 times as much waste as Millersville. At its peak year, 1997, PST received 7&1/2 times that of Millersville. *The landfill operated without a liner and leachate collection system.*

The Maryland Department of the Environment (MDE) is currently reviewing ground-water monitoring reports required of the operator, Waste Management Inc. Monitoring will continue for at least 5 years after closure. Additional monitoring is required under ground & surface water discharge permits, which are renewed every 5 years. Monitoring may be discontinued at the end of these permits if MDE concludes there is no further need.

As a part of the County's approval of the landfill zoning, a Community Benefit Agreement was established in 1991 to "ameliorate" impacts on neighboring property owners and neighboring citizens caused by the PST Rubble landfill on Sands Rd in Harwood. The County is now preparing to distribute the final moneys in the fund (approximately \$120,000). Previous distributions of over \$800,000 have funded school equipment, church parking lots, and the like.

At the request of the Harwood Civic Association (HCA) the Chesapeake Environmental Protection Association (CEPA) has applied for a grant of the remaining funds to secure independent professional analysis of ground water monitoring reports. HCA wants to be able to independently verify test results and, if necessary, challenge decisions and conclusions by regulatory agencies regarding the need to continue monitoring the safety of drinking water wells in the vicinity of the PST landfill. In addition, if MDE allows Waste Management to cease monitoring, collecting, testing and evaluating test results would be

continued using these funds. In light of the potentially serious threat to public health, reserving the entire remaining balance of the Community Benefit Fund seems prudent. The estimated balance is \$112,000.

A committee chaired by Councilman Ed Reilly will soon bring grant recommendations to the County Executive and County Council. It will be most valuable for residents to express their support for this request to Councilman Reilly and County Executive Leopold.

9. Provided start-up support to the Lothian Civic Association
10. Initiated new project to address recreation center concerns
11. Engaged several hundred citizens in civic awareness and direct action, demonstrating that our community cares about vital issues affecting the quality of life in Harwood and the surrounding area

Letter from Ed Reilly, Council Member

Recreation Concerns in South County

The article in your recent edition about recreation needs in South County highlights a large number of issues. I would like to touch on a few which may provide some background on issues and attitudes about South County Parks and Rec.

HCA President Mike Lofton and I recently met with Franklyn Chaney and the staff at the South County Recreation Center. After a brief tour, we sat and discussed a variety of issues. The staff is very interested in resident input identifying new programs that could be hosted at the center. They have currently on-going programs of pottery and dance. There is a basketball gym in the building that, for the majority of the winter, is used by various organized youth teams for basketball practice. This puts a great deal of time off the calendar for other uses of the one large room in the building.

Mr. Chaney has indicated that he will provide a map of beaches available for walking, hiker/biker paths and picnic areas through out South County. We will be making those available for your use in future newsletters. We had a good discussion concerning horse paths and water sports access. These issues are more long term in nature and are on the table for discussion.

I can personally share with you that whenever we acquire a piece of property by the county, I am advocating the active and passive recreational uses for you with the Parks and Rec Dept. There have been a number of active sports parks acquired and developed over the past few years. Bell Branch in Gambrills, Davidsonville Park on Patuxent Road and Riva Park on Riva Road are some great examples of sports fields that have been developed. I will continue to work with your organization to implement the ideas and activities that have been addressed in the recreational survey which the prior newsletter mentioned.

Thank you for your continued commitment to our great county.
